## MESSAGE FROM THE CHAIR

On March 22, 2024, the Granite State Section held a joint meeting hosted by the Vermont Section. The speaker was Robert Freeman, a member of ISO/TC 176/SC 2/WG 29 "Revision of ISO 9001". His presentation was "ISO 9001:2025 A Preview of What's to Come!" He had a short presentation outlining the schedules and some of the major issues. He took the time to answer many questions and explained the process to discuss and decide on changes. The online meeting had the largest number of participants for the Vermont section.

March 27, 2024, saw the first in-person meeting of the Granite State section. Dan O'Leary spoke on "Understanding Attribute Lot Acceptance Sampling Plans". He explained the use of ANSI Z1.4 and the c=0 sampling plans revised by ASQ last year. Participants had copies of the tables and walked through examples. In addition, the presentation included an explanation of the binomial distribution and how it applies to attribute sampling.

Granite State is partnering with nearby sections to hold joint meetings. This can help bring a variety of topics to the members.

The Merrimack Valley, Vermont, and Worcester sections have invited Granite State members to join their meetings, even if they are not joint meetings. ## PROFESSIONAL DEVELOPMENT

**Cost of Quality**

CQA: IV.B.3 Audit Program Management and Business Applications – Business and Financial Impact – Cost of quality (COQ) principles

Identify, describe, and analyze the audit program's effect on the four COQ categories: prevention, appraisal, internal failure, external failure. (Analyze)

CQE: II.E The Quality System – Cost of Quality (COQ) Identify and apply COQ concepts, including cost categorization, data collection, reporting, and interpreting results. (Analyze)

Cost of Quality, COQ, is a financial method to help achieve an optimum balance in the allocation of resources related to non-conforming product. COQ uses financial information to help determine the optimum. Often the company's Chart of Accounts don't mesh with the COQ categories, which can raise difficulties with implementation.

COQ uses four cost categories as part of the analysis. They are:

Appraisal Costs – The costs incurred to determine the condition of a product, usually based on the "first time" appraisal.

Internal Failure Costs – The costs that would not be present if there were no nonconformances prior to shipment to the customer.

External Failure Costs – The costs that would not be present if there were no nonconformances after shipment to the customer.



Prevention Costs – The costs incurred to minimize the appraisal costs and the failure costs.

Determining these costs is not always easy from a traditional Chart of Accounts. For example, production operators may check product on the line. This is an Appraisal Cost, but is usually rolled up in the direct labor cost to produce the product. Similarly, maintaining an IM&TE calibration program is an Appraisal Cost, but might show up as an expense charged to the Quality Department.

Some examples of COQ elements are:

Appraisal Costs Incoming Inspection In-process Product Verification Final Product Verification

Internal Failure Costs Rework Repair Scrap Corrective Action Costs Machine Downtime

External Failure Costs Warranty Costs Returned Product RMA Processing Time

Prevention Costs Quality Planning Training Programs Preventive Action

A COQ program determines which costs to capture, the analysis method, actions based on the results, and management reporting.

The costs fall into the four categories, but the real action is in the cost breakdown. This means either collecting actual costs through the finance system or making good estimates.

Analysis typically falls into two parts. The first determines the comparison basis and the second determines the variance from the optimum point.




Express COQ as a percentage of some other relevant financial measure such as Sales Revenue or Cost of Goods Sold, COGS. Using a percentage is important to help compare over time and observe trends. For example, if sales are growing then the company will order more raw material which will increase the cost of incoming inspection, an appraisal cost. However, the incoming inspection cost should stay proportionate to the sales revenue. Similarly, if the field failure rate is constant then an increase in sales results in more failed devices increasing the external failure costs; the costs should stay proportionate to the sales revenue. An increase in quality costs with a proportionate increase in the base is normal; a nonproportionate change is of interest.

The optimum is a balance between the failure costs and the appraisal costs. The costs change as the nonconforming product rate changes and, at some point, achieve a minimum, the optimum point. See the figure below. The value of the minimum also includes the prevention cost, which is often fixed. For example, the cost of training on procedures is not usually a function of the product nonconformance rate.

When implementing COQ, one of the first steps is understand the optimum and where the firms is operating. This can help adjust the balance between the appraisal costs and the failure costs to move toward the optimum. For example, if the firm uses attribute lot sampling at incoming inspection, then implementing switching rules can reduce the appraisal costs without increasing the failure costs.

Reporting to management should include the percentage of cost of quality relative to the base. This suggests a trend chart for reporting. At each reporting interval, expect a downward trend, but there will be variability. Some periods will show an increase, so the overall downward trend is important, not so much the value at each individual period.





## **QUALITY QUESTION**

Question: When referring to a standard in a procedure or work instruction should we include the revision year? We make medical devices and have many references to ISO 13485. Should we refer to ISO 13485:2016 by adding the year of the current revision? I see the benefit in either argument, I just want to find out the best practice for something like this.

Response: While the question relates to medical device standards, the issue cuts across all industries.

There are two conventions. Without the revision, you are referring to a generic version. For example, "ISO 13485 provides requirements for a medical device QMS".

More often you are referring to a specific version. If your procedures refer to the standard, it should be the specific version, which is ISO 13485:2016, since it includes the requirements you are following.

If you market your device in the EU, then your QMS must follow the EU requirements in EN ISO 13485:2016/ A11:2021. You need to be clear about whether your QMS implements the international version or the EU version.

In most cases, it is best if the procedure does not refer to the standard. The procedures should tell the people involved how to perform the associated process. The reference to the standard doesn't usually add value or improve the effectiveness of the procedure. It only creates a need for massive revisions when the standard changes.

A more efficient approach is to refer to the standards in some master document, such as the Quality Manual. This identifies the specific versions in your QMS, but it doesn't require you to update lots of procedures when a standard is revised.
